ORDINANCE NO. 2011-14

AN ORDINANCE CREATING WATER EXTENSION DISTRICT NO. 2011-1 OF THE CITY OF WAYNE, NEBRASKA; ESTABLISHING THE OUTER BOUNDARIES OF THE DISTRICT; DESIGNATING THE SIZE, LOCATION AND TERMINAL POINTS OF WATER MAINS AND WATER LINES WITHIN SAID DISTRICT; AND REFERRING TO PLANS AND SPECIFICATIONS AND COST ESTIMATES AS PREPARED BY THE CITY'S CONSULTING ENGINEERS IN CONNECTION THEREWITH AND ON FILE WITH THE CITY CLERK.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF WAYNE, NEBRASKA:

Section 1. The Mayor and Council of the City of Wayne, Nebraska, hereby find and determine that it is necessary and advisable to extend the municipal water system beyond the existing system by the construction of water mains and water lines and appurtenant improvements and that for the purpose of constructing said water mains and related improvements, there is hereby created Water Extension District No. 2011-1 of the City of Wayne, pursuant to authority granted in Section 19-2402, R.R.S. Neb. 2007, as amended.

Section 2. The outer boundaries of Water Extension District No. 2011-1 shall consist of a tract of land located in Wayne County, Nebraska, being described as follows:

A tract of land located in the South 1/2 of the Southwest 1/4 of Section 12 and a part of the Southeast 1/4 of the Southeast 1/4 of Section 11, Township 26 North, Range 3 East of the 6th P.M. Wayne County, Nebraska, more particularly described as follows:

Beginning at the Southwest corner of Section 12, Township 26 North, Range 3 East and extending Westerly along the South Line of Section 11, Township 26 North, Range 3 East, 544.50 feet; thence Northerly along a line parallel to the West Line of Section 12, Township 26 North, Range 3 East, 824.72 feet; thence Easterly 544.50 feet, to a point on the West line of Section 12, Township 26 North, Range 3 East, said point being 1809.56 feet south of the West Quarter Corner of said section; thence Easterly along the North line of Western Ridge Third Addition, 1310.49 feet; thence Southerly along the East line of Western Ridge Third Addition 757.91 feet, thence Southerly parallel to the West line of Section 12, Township 26 North, Range 3 West, to South line of said section, thence Westerly to the Point of Beginning.

The size, location and terminal points of the water mains, water lines and other appurtenances in said District shall consist of the following:

Description of Work:

Construction an 8-inch PVC water main, beginning at an existing cross located approximately 52 feet North and 990 feet East of the Southwest corner of Section 12, Township 26 North, Range 3 East; thence extending Westerly in Highway 35 R-O-W a distance of 970 feet more or less; thence extending Northerly in City Street R-O-W a distance of 780 feet more or less. The work shall include excavation, valves, fire hydrants, bends, service line connections, bedding, fine grading and shaping, seeding and testing as required to construct Water Improvement District 2011-1 for the City of Wayne, Nebraska, in accordance with the plans and specifications prepared by Advanced Consulting Engineering Services.

Estimated Costs:

The engineer's estimate of cost includes contingencies, engineering costs, estimated construction costs.

Engineers Estimate of Construction Cost = \$80,000

Section 3. Reference is hereby made to the plans and specifications for said water extensions, which have been prepared by Advanced Consulting Engineering Services, special engineers for the City, and which, together with said engineers' estimate of the total cost for the proposed water extensions, have heretofore been filed with the City Clerk.

Section 4. The engineers' estimate of total cost for the proposed water extension improvements in said District is \$80,000.00.

Section 5. The Mayor and Council hereby find and determine that none of the properties located within said District are presently served by the City's existing system of water service and that said District constitutes an area of land located apart and outside the area served and benefited by said system and all of the property in said District is located within the City of Wayne, Nebraska or within one mile of the corporate limits of the City of Wayne, Nebraska.
